Financial ratings are an assessment of the strength and resources of an organisation. They are based on the organisation's history of borrowing and repayment, as well as the level of assets and level of debts. These ratings are provided by independent private companies known as Rating Agencies and are reviewed on a regular basis.

Two of the major ratings agencies are Standard & Poor's and Fitch. Their ratings for Irish Life are shown below.

- Irish Life is rated A+ by Standard and Poor's which is labelled as a 'Strong' rating.
- Irish Life is rated AA by Fitch. The AA rating definition is 'Very High Credit Quality'.

Both ratings are considered strong and are further evidence that Irish Life is a secure, low risk company with very strong capital reserves.
